III. Organizational restructuring

On June 29, 2023, the Company will conduct organizational restructuring. The details of organizational restructuring are as follows.

1. The Company will change its delivery structure in the R&D and Engineering as part of measures to strengthen the engineering structure, and establish new "Plant Project Planning Department" and "Plant Design Department" in order to facilitate efficient delivery using an operation-segregated delivery structure for large-scale projects and a new "General Plant Engineering Department" in order to facilitate efficient delivery using a seamless integrated delivery structure for small- to medium-scale projects.

Through this change, the Engineering Department of the pre-existing organization will be abolished.

2. The Planning and Administration Department under the R&D and Engineering will be abolished and a new "Planning Department" will be established as an organization dedicated to planning, and for

large-scale projects, a project manager system will be introduced to strengthen the delivery system. In addition, the Company will carry out initiatives to accelerate engineering process reforms, including the automation and efficiency of design through data utilization. A new "Management Department" will be established as an organization dedicated to administration.

- 3. For the purpose of accelerating the creation of business models that utilize digital technologies, the Company will integrate the "Digital Transformation Department" and the "Service Solutions Promotion Office" and establish a new "Data & Solution Promotion Department" under the Corporate Management and Planning.
- 4. With the aim of strengthening security measures and the system infrastructure, the Company will transfer the Information System Office from under the Operation Improvement Department in the Corporate Management and Planning to directly under the Corporate Management and Planning, and will renamed as the "Information Systems Department."

The Operation Improvement Department will be phased out and abolished as its various measures have transitioned to a practical stage within the departments using such measures.
